

2.3 GENERAL SAFETY INSTRUCTIONS

4 BEFORE FIRST USE

5 Use

- » The product is equipped with a memory function. The last mode used before switching off the product, will be the mode used when the product is switched on.
- » A minimum of 5 supports per metre must be used to support the weight of the light chain and avoid putting strain on the cable.
- » The product is equipped with a light sensor. The light chain will only switch on once the ambient light is below its threshold.

5.1 Using the product

- . Connect the stake to the pole.
- Slide the solar panel onto the pole.
- 3. Place the solar panel in a sunny location, so the built-in batteries can be charged for use.
- Press the **ON/OFF** button on the back of the solar panel to switch on the product. The first mode is active. Press the **MODE** button to change to the next mode. The product has 8 modes.
- COMBINATION -> IN WAVE -> SEQUENTIAL -> SLO-GLO -> CHASING/FLASH -> SLOW FADE -> TWINKLE/FLASH -> STEADY ON
- 5. To switch off the product, press the **ON/OFF** button on the back of the solar panel.
